

## SALARY AND OTHER REIMBURSEMENT LEGISLATORS RECEIVE UNDER THE PROVISIONS OF LAW - IN EFFECT AS OF JANUARY 1, 2017

### Regular, Special, or Organizational Session

Salary (NDCC § 54-03-20) \$177/calendar day

#### Additional compensation for (NDCC § 54-03-10)

Speaker of the House	\$15/calendar day

#### Reimbursement for lodging expenses (NDCC § 54-03-20)

Actual expenses not to exceed 90 percent of the GSA rate **(\$81.90 as of 10/1/16) per day plus any additional applicable state or local taxes in state**, subject to the maximum monthly session reimbursement of \$1,682 per month (30 times 70 percent of the daily lodging rate as determined by OMB as of 8/1/16).

Mileage - GSA rate as determined by OMB (53.5 cents per mile as of 1/1/17) per mile for one round trip each calendar week going to and from the meeting of the Legislative Assembly during a regular session and one trip going to and from the organizational session. If travel is by common carrier, reimbursement may not exceed the cost of coach fare and may not exceed one and one-half times reimbursement for travel by motor vehicle.

**NOTE:** Legislators who live in districts outside Bismarck are allowed daily round trip mileage reimbursement of the GSA rate as determined by OMB (53.5 cents per mile as of 1/1/17) or lodging reimbursement of up to a maximum of 90 percent of the GSA rate as determined by OMB (\$81.90 per night) plus any additional applicable state or local taxes on lodging when mileage is not claimed up to the maximum monthly reimbursement of \$1,682. (NDCC §§ 54-03-20 and 54-06-09)

### Other

Monthly compensation (NDCC § 54-03-20) \$495/month

Additional monthly compensation for Majority and Minority Leaders  
(and the Chairman of the Legislative Management if not a Majority or

### Interim

Compensation for attendance at meetings of the Legislative Management  
and its committees (NDCC § 54-35-10) \$177/day

#### Reimbursement for meals, lodging, and mileage at the following statutory rates

Meals - Not to exceed \$35 per day in state effective August 1, 2013, and equal to the amount of the federal per diem meal rate for the respective locations for out of state (NDCC § 44-08-04):

Lodging - Actual expenses not to exceed 90 percent of the GSA rate **(\$81.90 as of 10/1/16) per day plus any additional applicable state or local taxes in state**; actual expenses out of state (NDCC § 44-08-04)

Mileage - GSA rate as determined by OMB (53.5 cents per mile as of 1/1/17); 18 cents per mile by motor vehicle 300 miles beyond state border; and one and one-half times actual air mileage at the GSA rate (80 cents as of 1/1/17) by private airplane (NDCC § 54-06-09)
